- 2. HHD shall treat all information as confidential and the exclusive property of Company, and agrees not to disclose any of the Information to any third party without first obtaining the written consent of Company.

  - (d) was lawfully received by HHD from some third party having a right of further disclosure.
- 5. HHD agrees that, at Company's request, it shall return to Company all parts of the Information provided by Company in documentary form and will return or destroy any copies thereof made by HHD, its directors, officers or employees.
- 6. Nothing herein contained shall be deemed to grant to HHD any rights or licenses under any patent applications or patents or under any know-how, technology or inventions of Company.
